BACKGROUND:

Presenter: Jason Sweet, Bonneville: Executive Manager Fish and Wildlife

Summary: Bonneville will provide an update on the Fish and Wildlife Direct Program's

expense and capital budgets for Fiscal Year (FY) 2024, along with past

spending levels for the direct program.

Relevance: Bonneville's *direct program* supports the Council's project-level

recommendations. There are currently over 300 ongoing projects, most of which have been reviewed and recommended by the Council. These projects address one aspect of mitigation for the impacts of hydro-electric

dams in the Columbia River basin.

Mitigation also occurs via the Council's Fish and Wildlife Program through the *reimbursable program* which includes the capital construction and operations and maintenance occurring on-site at the dams, as well as through actions called for in the Program that are directly *implemented by the agencies* that manage and operate the federal and non-federal dams, such as actions related to flow management and water quality. Those expenditures are not addressed in the direct program start of year budget.

Workplan: Program implementation: Tasks A (Project review and implementation); H (Implementation of the Council's Fish and Wildlife Program).

(Implementation of the Council's Fish and Wilding Frogram).

Background: The Council received a letter from Bonneville regarding their Fiscal Year 2024 Start of Year budget information dated October 10, 2023. Bonneville's FY 2024 direct program expense budget is \$297,474,498 and \$26,872,238 for capital. Attached to the letter is an excel spreadsheet with project-specific budget information. The staff appreciates receiving this detailed information.

The letter notes that consistent with past practice and experience, Bonneville over-budgets for mitigation because there is inherent underspend for legitimate reasons. This practice in turn ensures that overall, and across the F&W Program, as much of the available annual program budget is used for project implementation as possible.

RE: Bonneville's Fiscal Year 2024 Start of Year Budget Information

Dear Chairman Allen:

The purpose of this letter is to provide the Northwest Power and Conservation Council (Council) with notice of Bonneville Power Administration's (Bonneville) Fish and Wildlife (F&W) Program planning budget for federal fiscal year (FY) 2024.

The start of year (SOY) budget shown below, and in the attachment, reflects F&W Program planning status as of October 1, 2023. Individual SOY project budgets for FY2024 are consistent with Bonneville's budget commitments in applicable agreements, and all SOY budgets have been uploaded into the contract management system, cbfish.org.

Our total F&W Program-level FY2024 SOY planning budget is \$324,346,736, which includes \$297,474,498 for expense, and \$26,872,238 for capital. Those same values for FY2023 SOY were \$285,649,539, which included \$268,716,710 for expense, and \$16,932,829 for capital (table 1). Project-specific budget information can be found in the attached excel spreadsheet. Consistent with past practice and experience, Bonneville over-budgets for mitigation because there is inherent underspend for legitimate reasons. This practice in turn ensures that overall, and across the F&W Program, as much of the available annual program budget is used for project implementation as possible.

Project number 2023-003-00 Reserves Distribution Clause - Asset Management was created to facilitate our BP-22 Reserves Distribution Clause (RDC) and is a distinct funding source separate from our Fish & Wildlife Program. Therefore, we are reporting that FY2024 budget amount separately to avoid the perception that the Program budget increased by that additional amount, when in fact it had not. The remaining \$6.9M from the BP-22 RDC for Fish and Wildlife Program hatcheries will be distributed in future fiscal years.

As this fiscal year begins, there is potential for additional projects to be added to the Program in FY2024 as Bonneville expects to finalize implementation agreements currently in development. Bonneville has also entered into an agreement with the U.S. Forest Service to leverage mitigation

opportunity in the John Day River Basin, which was the genesis of project number 2023-004-00 *Pacific Northwest Aquatic Restoration Partnership in the John Day River Basin*. Bonneville will be engaging with Council staff on next steps for reviewing the associated work.

Bonneville's Fish and Wildlife Division remains focused on continuing a disciplined approach to managing the F&W Program. We are closely tracking and reporting progress on budget execution by reviewing expenses on a monthly basis. We will continue to keep Council staff updated on expenditures, as well as any necessary budget adjustments, in our monthly coordination meetings.



Fish & Wildlife EXP Funding Level Trends


FY08/09 - FY24/25 Rate Case Levels

FY08-FY23 Actuals to Rate Case with % Execution (in millions)






FY24 F&W Direct Program Budgets




FY24 FW IPR Capital Budget

Combined Capital and Expense Budgets since 2008


BPA F&W PROGRAM HISTORICAL EXPENDITURES

FY24 Budget Summary

- Based on BP-24 IPR cost projections, BPA will implement an 8.7% increase in overall fish and wildlife costs at the program level for FY24 and FY25.
- This is the largest percentage increase in projected F&W Program costs since 2012.
- The estimated cost increase stemmed from inflationary pressure on the cost of materials, equipment, and staffing across the Fish and Wildlife Program, new fish and wildlife obligations, and necessary investments in existing mitigation assets.
- Bonneville implemented a 4.4% increase to all projects that did not have a previous commitment to annual budget adjustments.
- Increased budget for non-routine asset management for hatcheries, irrigation fish screens, and lands.
 - Does not include the additional \$50M in non-routine hatchery O&M implemented through the BP-22 Reserve Distribution Clause.

- To balance the risk of overspending and underspending budgets, Bonneville will continue to refine our business management practices to monitor throughout the year and adjust as warranted.
- In partnership with the Council, Bonneville will continue to focus and emphasize the program achievements that directly benefit fish and wildlife species.
- Bonneville will work to refine protocols to share information with the Council and staff regarding project changes.
