Council Meeting Summary December 10 & 11, 2024 via Webinar

December 10, 2024

Council Chair Jeff Allen brought the meeting to order at 8:04 a.m. Pacific Time. Council Members Ginny Burdick, KC Golden, Doug Grob, Mike Milburn, Louie Pitt Jr., Thomas L (Les) Purse, and Ed Schriever were in attendance virtually. The next Council meeting is scheduled for January 14 & 15 in Portland, OR and via webinar.

Council Meeting Agenda Items

- 1. Council Work Session and Fish and Wildlife Amendment Preparation
 - a. Fish and Wildlife Program amendments

Fish and Wildlife Division Director Patty O'Toole and General Counsel John Shurts presented a review of the draft letter calling for Fish and Wildlife Program amendment recommendations. Staff discussed with the Council the first draft of the letter, based on staff recommendations and feedback from Council members on the draft outline at the November meeting. The letter contains information about the process, including why the

Council needs to call for recommendations to amend the program at this time, the requirements for that request, and instructions for how people should submit their program amendment recommendations to the Council. The estimated timeline for this process was shared and the Council is on track to make the decision to send the letter in January 2025. The staff will take the input from members at the December meeting and incorporate that feedback into the next draft.

b. Staff report on Program goals and objectives and latest developments for the Program tracker

Biologist for Program Performance Kris Homel and Fish and Wildlife Program Scientist Kate Self presented on progress toward meeting goals and objectives, as described in the Fish and Wildlife Program 2020 Addendum. Program goals include objectives for salmon and steelhead, other native aquatic species, wildlife, ecology/habitat, and communication, assessment and coordination. For each goal and objective, staff presented a summary of background and context, data on progress where available (typically using Strategy Performance Indicators), and identified where edits to the text of the goal or objective could better match existing data sets or be more quantitative or trackable. This work is part of a broader effort by staff to provide critical information to the region and the Council in advance of the next amendment process.

2. Report on Regional Demand Response Efforts

Resource Analyst Joe Walderman presented a regional "round-up" that showcased the progress made across the region to develop demand response programs and how they support either regional or individual utility needs. 4. Data Center Landscape Panel

Chair Jeff Allen and Vice Chair KC Golden introduced Brian Janous with Cloverleaf Infrastructure, Dr. Sarah Smith with the Lawrence Berkeley National Laboratory, and Consultant Robert Cromwell to present a high-level look at data centers, with details surrounding their operation and energy needs, the key opportunities and challenges for utilities in serving this new load, and the policy and planning issues that the Council should consider in advance of the work on the Ninth Plan. After short opening remarks from each presenter, Member Golden and Chair Allen led a panel discussion that covered a range of topics.

5. Virtual Power Plant Discussion

Resource Analyst Joe Walderman introduced Franco Albi with Portland General Electric and Shawn Grant with PacifiCorp, who spoke to their utilities' progress on creating and growing virtual power plants (VPPs) and how they work to maintain a reliable and adequate electric system for their customers. Details were presented on how these utilities are taking advantage of distributed energy resources and enhanced communication capabilities and software to use demand side resources in new ways through VPPs.

6. Staff Report on Program Performance: Habitat Categorical Assessment (continued from November)

Biologist for Program Performance Kris Homel and Project Review and Implementation Manager Mark Fritsch continued their November habitat categorial assessment presentation with a focus on habitat protection. Staff described Program strategies, measures, and implementation status using data from the Strategy Performance Indicators, along with other sources. The implementation examples emphasized discussion points rather than technical details. The presentation concluded with a discussion of Program-scale observations from these examples. This assessment, along with recent categorical assessments on the hydrosystem and artificial production, provides critical information to the Council and region on the implementation and performance of the Program in anticipation of the upcoming Program amendment.
