SUBJECT: Update on Anadromous Fish Habitat and Hatchery Review

BACKGROUND:

Presenter: Council staff

Summary: The Anadromous Fish Habitat and Hatchery Project Review process will

begin in early February. Staff will provide a brief status report on the review process, schedule, and efforts to refine project objectives and

deliverables for the 134 projects.

Relevance: Section 4h(10)(D) of the Northwest Power Act directs the Council to

review projects proposed for funding by Bonneville to implement the Council's Fish and Wildlife Program. The Council engages in this review process with the assistance of the Independent Scientific Review Panel (ISRP). The Council and Bonneville work together to develop the

information necessary to make the review process successful.

Workplan: Fish and Wildlife Division: Program Implementation (2014 Program and

2020 addendum); Project review.

Background: The Anadromous Fish Habitat and Hatchery Project Review is the last

category of this review cycle. Staff anticipates that there will be

approximately 134 projects in this review. These projects include hatchery operation and maintenance (O&M), fish screen O&M, habitat restoration

The review is scheduled to be initiated with the managers the first week of February 2021. Council and Bonneville staffs have worked together to confirm the list of projects in this category and to update the proposal form template to capture key aspects related to this specific set of projects and to further refine requested information to get a better understanding of methods used by the sponsors to achieve their objectives.

This review is limited to projects that are currently being funded under the Program (i.e., ongoing projects). The general guidance for this review is to use Fiscal Year 2021 project budget as the sideboards for the work proposed. This aligns to Bonneville's Strategic Plan. Bonneville's statements have indicated that they intend to manage Fish and Wildlife Program costs at or below the rate of inflation, inclusive of any new obligations. However, sponsors of ongoing projects may wish to describe new work elements, phases, or objectives for their projects based on adaptive management or new priorities, considering budget constraints.

This is the largest group of projects (134) in the current review cycle; therefore, additional time was added to several steps of the review process to assist the project sponsors and the Independent Scientific Review Panel. Please see Attachment 1 listing the 134 projects in this review.

Following is the review schedule that reflects a rescheduled start date and the allowance of additional time in key steps. You will note that the overall time frame has increased from the "standard" nine months to 14 months.
